The programs offer rebates to builders of single and multifamily ENERGY STAR® qualified homes and for the incorporation of high-efficiency appliances in newly constructed single-family residences of four units or fewer or multifamily residences of 5 units or more within Questar Gas's Utah service area.

Terms and Conditions

Rebate availability

The Questar Gas ThermWise Builder and Multifamily Rebate Programs have been approved by the Public Service Commission of Utah and may be subject to change or modification at any time. Builders of newly constructed single and multifamily homes are eligible to receive rebates for the purchase and installation of high-efficiency equipment and/or for building ENERGY STAR® qualified homes. For rebates under the ThermWise Builder Rebates Program, new equipment purchased and installed and new homes certified as ENERGY STAR on or after January 1, 2007 are eligible. For rebates under the ThermWise Multifamily Rebates Program, new equipment purchased and installed and new homes certified as ENERGY STAR on or after January 1, 2008 are eligible. Applications must include all information requested and failure to provide this information may result in the delay or denial of the rebate.

Rebate eligibility

Invoices or receipts may be required for each measure except whole home certifications (see application or ThermWise.com for more details). Rebates for newly constructed single or multifamily projects will be payable to the home builder only (including owner-builders).

Rebate qualification

If equipment is returned after rebate is paid, Questar Gas will be reimbursed the rebate with penalty including associated legal and/or collection related costs. Qualifying equipment models may be found on ThermWise.com or by calling 1-866-699-6034. Equipment must be installed at a newly constructed residence at an address with an active Questar Gas Service Line Agreement. Qualifying new residences for the ThermWise Builder Rebates Program include single-family houses and dwellings with up to four separately-metered units per building located within Questar Gas's Utah service area. Qualifying new residences for the Multifamily Rebates Program include multifamily dwellings with five or more units per building located within Questar Gas's Utah service area. Builders in Questar's Wyoming service area are not eligible for rebates.

Application details

Builder understands that, in the case of a single family ENERGY STAR or High Performance Home, their HERS provider may submit the Application, in the form of an Inspection Worksheet, on their behalf. The Application may be submitted by the builder, if desired. Only one rebate will be paid per site address, however. Builder further understands that there may be inspections on the ENERGY STAR or High Performance Homes they build by a representative of the Program for Quality Control purposes. Questar Gas reserves the right to verify information provided on the application. If your application is selected for verification, it will not be processed until the verification process is satisfactorily completed. Questar Gas issues rebates in the form of checks, not utility-bill credits. Questar Gas is not responsible if your supplier provides inaccurate information about the amount and/or conditions of the actual rebate, and Questar Gas will not pay rebates for equipment that is mislabeled or misrepresented by dealers regarding rebate qualifications. Builders receiving rebates under one ThermWise Rebate Programs may not receive rebates for the same equipment or home under other Questar Gas programs.

Rebate limitations and limitation of damages

Payment of the rebate by Questar Gas does not warrant the performance of qualifying/installed equipment and does not warrant that the qualifying/installed equipment will deliver any specified amount of energy or cost savings. The builder shall independently evaluate any information related to the qualifying equipment. Neither Questar Gas, its parent company, affiliates, subsidiaries, officers, employees, nor its contractors make any warranty, expressed or implied, or assume any legal liability or responsibility for the accuracy, completeness or usefulness of any information, estimated savings, benefits, products or processes disclosed, or represent that its use would not infringe on privately-owned rights.
