Rebates will be paid only for completed applications including all required receipts, certificates and reports. A signed **Builder Participation Agreement** is required in order to receive rebates from the **ThermWise Builder Rebate Program**. Please go to <http://www.thermwise.com/builder/BuilderRebates.html> to download the form and submit with your rebate application.

1. **Build** a new Single Family or Multifamily dwelling featuring one or more of the ThermWiseSM Builder Rebates measures (noted on page 1). Please call the **ThermWise Trade Ally Hotline at 877-699-6035** for production building and multiple homes options.
2. **Complete application** providing information for **all** applicable fields.
3. **Collect documentation** noted below:
 - For each **clothes washer, clothes dryer, furnace, boiler and water heater rebate**,
 - Itemized receipt with date of purchase, description of equipment, manufacturer, model number and serial number of equipment.
 - For each **ENERGY STAR whole-house rebate**, a third-party home energy rater (HERS) must verify the home performance and provide supporting documentation, including:

ENERGY STAR Certification	ENERGY STAR Certificate (required of all homes - individually rated and sampled)
ENERGY STAR Certification + furnace and/or water heater rebates	ENERGY STAR Certificate and two (2) Home Verification Summaries showing ENERGY STAR whole-house performance was achieved without consideration of the high-efficiency furnace(s) and/or water heater(s). (Additional reports are required only for homes individually rated.)
High-Performance Home	Exceed the 2006 International Energy Conservation Code (IECC) by at least 50%. Rebate only available to single family properties.

6. **Allow** approximately six weeks for your rebate check to arrive after all documentation has been received by Questar Gas.

Terms and Conditions

Rebate availability

Questar Gas's ThermWise[®] Builder Rebates Program has been approved by the Public Service Commission of Utah and may be subject to change or modification at any time. All equipment must be new and must be purchased and installed prior to submitting a rebate application, and must have been purchased and installed on or after January 1, 2007 for all Single Family dwellings and January 1, 2008 for all Multifamily dwellings. Applications must include all information requested. Failure to provide this information may result in the delay or denial of the rebate.

Rebate eligibility

Invoices or receipts are required for each measure except whole home certifications. Rebates for furnaces, water heaters, boilers and/or solar hot water systems installed in newly constructed homes and ENERGY STAR certification rebates will be payable to the home builder only (including owner-builders).

Rebate qualification

If equipment is returned after rebate is paid, Questar Gas will be reimbursed the rebate with penalty including associated legal and/or collection related costs. Qualifying equipment models may be found on ThermWise.com/builders.html or by calling 1-866-699-6034. Equipment must be installed at a newly constructed residence at an address with an active Questar Gas Meter. Qualifying new residences include single and multifamily houses and dwellings with five or more separately-metered units per building located within Questar Gas's Utah service area. Builders in Questar's Wyoming service area are not eligible for builder rebates.

Application details

Questar Gas reserves the right to verify information provided on the application. If your application is selected for verification, it will not be processed until the verification process is satisfactorily completed.

Questar Gas issues rebates in the form of checks, not utility-bill credits. Questar Gas is not responsible if your supplier provides inaccurate information about the amount and/or conditions of the actual rebate, and Questar Gas will not pay rebates for equipment that is mislabeled or misrepresented by dealers regarding rebate qualifications. Builders receiving rebates under the ThermWise[®] Builder Rebates Program may not receive equipment purchase and installation rebates for the same equipment under other Questar Gas programs.
