All steps are required unless otherwise noted; rebates will be paid only for completed applications including all required proofs of purchase, certificates and reports.

## 4) Attach Proof of Purchase or ENERGY STAR Certificate

Attach Proof of Purchase (receipt or invoice) and/or ENERGY STAR Certificate for your dwelling. Your retailer or contractor can provide a proof of purchase for your qualified product.

If your home is ENERGY STAR qualified, your authorized HERs rater can provide required documentation, including the ENERGY STAR Certificate and the HERC reports, if necessary. If they submit an application on your behalf, they will not be required to submit a proof of purchase for any high-efficiency equipment.

### **Check delivery**

Rebate checks are issued within approximately six weeks upon receipt of a completed and approved rebate application.

## Terms and Conditions

### **Rebate availability**

The Questar Gas® ThermWise® Builder Rebates Program has been approved by the Public Service Commission of Utah and may be subject to change or modification at any time. All equipment must be new and must be purchased and installed prior to submitting a rebate application. Qualifying products purchased on or after January 1, 2007 are eligible for a Single Family Program rebate. Qualifying products purchased on or after January 1, 2008 are eligible for a Multifamily Program rebate. Applications must include all information requested. Failure to provide this information may result in the delay or denial of the rebate.

### **Rebate eligibility**

Invoices or receipts are required for each measure except whole home certifications. Rebates for furnaces, water heaters, boilers and/or solar hot water systems installed in newly constructed homes and ENERGY STAR® certification rebates will be payable to the home builder only (including owner-builders).

### **Rebate qualification**

If equipment is returned after rebate is paid, Questar Gas will be reimbursed the rebate with penalty including associated legal and/or collection related costs. Qualifying equipment models may be found on ThermWise.com or by calling 866-699-6034. Equipment must be installed at a newly constructed residence at an address with an active Questar Gas Meter. Qualifying new residences include single family and multifamily houses and dwellings with five or more separately-metered units per building located within the Questar Gas Utah service area. Builders in Questar's Wyoming service area are eligible for builder rebates. Visit ThermWise.com for details regarding the Wyoming ThermWise Program.

### **Application details**

Questar Gas reserves the right to verify information provided on the application. If your application is selected for verification, it will not be processed until the verification process is satisfactorily completed.

Questar Gas issues rebates in the form of checks, not utility bill credits. Questar Gas is not responsible if your supplier provides inaccurate information about the amount and/or conditions of the actual rebate, and Questar Gas will not pay rebates for equipment that is mislabeled or misrepresented by dealers regarding rebate qualifications. Builders receiving rebates under the ThermWise Builder Rebates Program may not receive equipment purchase and installation rebates for the same equipment under other Questar Gas Programs.

The builder hereby transfers to Questar Gas all "Environmental Attributes" attributable to the Qualifying Equipment or its operation. "Environmental Attributes" means those aspects, claims, characteristics and benefits of avoided energy use associated with the Equipment.
