It is the applicant's responsibility to complete the application and submit it with the required supporting documentation. Rebates are available only for customers living in EXISTING single family dwellings (not newly constructed homes) of up to and including four units that have primary gas heating. Measures must be installed prior to requesting a rebate. The application must be signed by the customer holding the Questar Gas® account. Rebates will not be paid for ineligible or incomplete applications.

## Attic Insulation

Effective January 1, 2010, attic insulation projects must meet minimum state energy requirements to qualify for an attic insulation rebate. Attic insulation projects must achieve a total minimum level greater than or equal to R-38 and not to exceed a level greater than R-60 (to meet current energy building codes and align with current DOE recommendations). Rebates will not be paid on applications that do not meet these outlined requirements.

**Tier 1** - You must install at least the level R-19 of new insulation achieving a total minimum level of R-38 and not to exceed a level of R-60. This Tier will be paid at \$0.20 per square foot.

**Tier 2** - If by completing the requirements of Tier 1 and the insulation does not meet the minimum required level of R-38 and does not exceed a level of R-60, you may also install a minimum level of R-11. Your final insulation must achieve a total minimum level equal to or greater than R-38 and not to exceed R-60. This tier will be paid at \$0.07 per square foot.

### Rebate Availability

The Questar Gas ThermWise Weatherization Program has been approved by the Public Service Commission of Utah and may be subject to change or modification at any time. All efficiency measures must be new, must be purchased and installed prior to submitting a rebate application, and must have been purchased and installed on or after January 1, 2007. Applications must include all information requested. Failure to provide this information may result in the delay or denial of the rebate.

Efficiency measures must be installed in single-family houses or in dwellings of up to four units within Questar Gas's Utah service area. ### Application Details

Applications are subject to verification by Questar Gas. If your application is selected for verification, it will not be processed until the verification process is satisfactorily completed.

Questar Gas issues rebates in the form of checks, not utility bill credits. Questar Gas is not responsible if your retailer or contractor provides inaccurate information about the amount and/or conditions of the actual rebate. Questar Gas will not pay rebates for efficiency measures that are mislabeled or misrepresented by dealers regarding rebate qualifications.

The customer hereby transfers to Questar Gas all "Environmental Attributes" attributable to the qualifying measure or its operation. "Environmental Attributes" means those aspects, claims, characteristics and benefits of avoided energy use associated with the measure(s). Environmental Attributes include all environmental benefits, avoided emission characteristics, credits, allowances, reductions, offsets, and benefits associated with the savings of energy and the reduction of generation from nonrenewable energy resources, including any avoided emissions of carbon dioxide, methane, and any other greenhouse gases, but do not include any tax benefits or credits associated with the measure.
