## INSTRUCTIONS

If you are a property owner not listed on the account where qualified equipment was installed and you would like the rebate check to be made payable to you, it is necessary to complete this form and attach it to your ThermWise Rebates Program application so we are able to verify ownership of the property.

**To receive the rebate, you MUST provide a copy of the property tax record for the install address, clearly showing the following:**

1. Date of report
2. Property tax physical address
3. Full name of Property Owner (this name must match the name printed below)

**IMPORTANT:** Please keep a completed copy of this form with copies of the entire submission for your records.

## W-9 REQUIREMENT

As a condition of payment, Applicant shall provide a completed Form W-9 identifying the applicant's correct tax information. If there are any changes to information, such as address, a new Form W-9 form must be submitted prior to payment being issued. Payment will be withheld until Applicant has submitted a valid Form W-9 or corrected any identified information mismatches.
